Agents selling Medicare Advantage are required to complete the 2024 Independence Medicare Certification process via Litmos.

#### Step 1: 2024 Independence Medicare Certification Training

 The agent will receive an email with instructions on how to log-in and complete the 2024 Independence Medicare Certification Process. A sample email has been provided below.
