
Agents selling Medicare Advantage are required to complete the 2024 Independence Medicare Certification process via Litmos.

Step 1: 2024 Independence Medicare Certification Training

 The agent will receive an email with instructions on how to log-in and complete the 2024 Independence Medicare Certification Process. A sample email has been provided below.

Upon receipt of the invitation email (referenced-above), you will need to enter your credentials and login to the system.







Each agents is required to complete the following courses within the assigned Learning Path. You can do so by clicking on "Start this learning path"





Step 5: Background Check / AHIP approval and certification completion

Once all the required steps and courses are completed you will need to upload your 2024 AHIP Certificate of completion. This will then initiate the background check component of certification.

You will be sent an email from our background check vendor CheckR requesting you start the background check (see below).





Once the background check results and AHIP certificate is approved you will receive the following
