Your Easy Path to 2026 Certification

1 Access Producers' University through [CignaforBrokers](#) and click on MyLearning. Recommended browsers are **Chrome** and **Edge**.

2 Complete all the required training on your learning track or take advantage of our **test-out** option!

3 You must score at least **85%** to pass each exam. You have **3 total attempts** — but **failing the test-out** exam leaves you with only **2 remaining**.

4 Launch and complete **AHIP*** directly from your track at our discounted rate of **\$125**. Launch **Pinpoint**** from your track at our discounted rate of **\$99.95**. You can also upload a certificate from **NABIP**.

*If you have already completed a AHIP with another carrier or directly with AHIP, you can still transmit your completion to us by simply logging on to the AHIP portal using this [link](#).

**Please note that not all carriers accept the Pinpoint Medicare Training.

5 Check **My Transcript** to confirm all required trainings are **100% complete**.

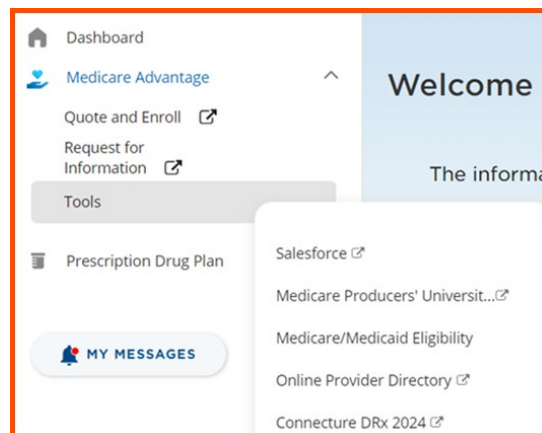
Certification – Making It Easier for You

- Returning agents are again **exempt** from completing the **Selling with Integrity** course.
- There is no separate PDP certification for agents who hold licenses in our MAPD states. The MAPD Products and Benefits Overview qualifies you to sell our Standalone PDP plans.
- Agents who only hold licenses in states where HealthSpring does not have an MAPD product will be assigned the standalone PDP course on the PDP-Only track.
- Attestations course is included on the test-out track and must be completed whether or not you choose the test out option. Attestations is required to be ready to sell.
- Take advantage of the **\$50 AHIP upfront discount** - launch AHIP from Producers' University.

For 2026, all agencies must have an active writing principal who completes all certification requirements.

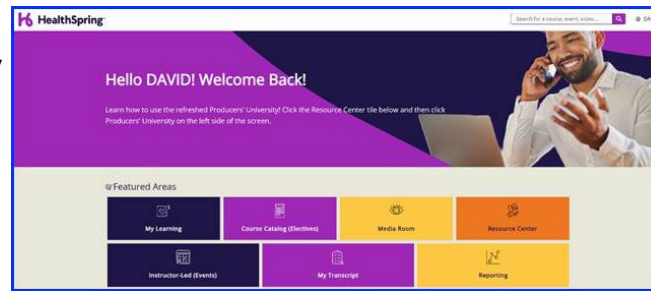
1 Access Producers' University from Cigna for Brokers

- Login to [Cigna for Brokers](#)
- Select **Medicare Advantage** in the top left corner
- Select **Tools** from the next drop-down menu
- Then select **Medicare Producers' University**

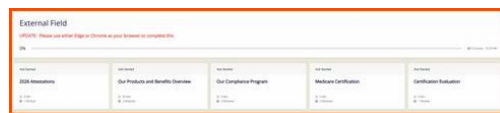


2 Complete All the Required Training on your Learning Track or take advantage of the Test-Out Option

- Select **My Learning** from the **Producers' University** menu
 - Two course options to choose from:
 1. **External Field Learning Track**
 2. **Test-Out Track**



External Field Learning Track



- 3 Attempts to pass each course

Test-Out Track



- Only 1 Attempt to Test-Out

3 Pass Each Exam with a Score of at least 85%

- Returning agents are exempt from completing the ***Selling with Integrity*** course
- Must achieve 85% or better on test
- Must complete 2026 Attestation in order to be considered Ready to Sell
- Completing 2026 Certifications retroactively certifies brokers to write for the remainder of 2025

4 Launch and Complete AHIP Directly from your Track at our Discounted Rate of \$125. You Can also Upload a Certificate from NABIP (NAHU)

- Upload or Complete AHIP, NABIP (NAHU) or Pinpoint Medicare Certification
 - Launch AHIP from Producers' University to receive a \$50 upfront discount
 - If AHIP is already complete, [click this link](#) and login to the AHIP site to transmit your completion certificate to Cigna Healthcare

- 1** Access Product University through [CignaforBusiness](#) and click on My Learning. Recommended browser is Chrome or Edge.
- 2** Complete all the required training on your Learning track or take advantage of our test-out option!
You must score at least 85% to pass each exam. You have 3 total attempts – but failing the test-out exam leaves you with only 2 remaining.
- 3** Launch and complete ANIPSM directly from your track at our discounted rate of \$125.
If you have never completed a self-assessment course or directly with ANIP, you can still measure your completion as if you signed on to the test-out period using the link. Please see the test-out period under the Home/Welcome banner.
- 4** Check My Transcript to confirm all required trainings are 100% complete.

- Returning agents are again exempt from completing the Selling with Integrity course.
- There is no separate PDF certification for agents who hold licenses in our MAPD states. The MAPD Products and Benefits Overview qualifies you to sell our Standalone PDP plans.
- Agents who only hold licenses in states where HealthSpring does not have an MAPD product will be assigned the standalone PDP course on the PDP-Only track.
- Abandonment course is included on the test-out track and must be completed whether or not you choose the test-out option. Abandonment is required to be ready to sell.
- Take advantage of the \$50 ANIP sign-up discount – launch ANIP from Product University.
